Each publication, press release or other document that cites results from NIH-supported research or training must include an acknowledgement of NIH grant support.

The following templates may be used to cite CTSA grant support:

**CTSA Grant Acknowledgement** – to be used by all investigators who receive pilot award funds and/or who access and utilize UTSW CTSA resources to include: statistical consultation/support, research design consultation, data management support, tuition for training programs, PCIR/GCRC, etc.
