## Virtual Visits Powered by MDLIVE<sup>®</sup>

Virtual visits, powered by MDLIVE®, offers members an opportunity to reach doctors using a phone, mobile App or online video for non-emergency medical and behavioral health issues. Starting September 1, 2019, access is available 24 hours a day, seven days a week from anywhere. Members can speak to a doctor or schedule an appointment at a time that works best. With virtual visits, members get:

- 24/7 access to independently contracted, board-certified doctors
- Access by online video, mobile app or phone
- E-prescriptions sent to a local pharmacy, when appropriate

Virtual visits doctors can treat a variety of health issues, such as:

- Allergies
- Ear problems (age 12+)
- Pink eye
- Asthma
- Fever (age 3+)
- Rash
- Colds and flu
- Nausea
- Sinus infections



Members can also speak with a licensed counselor, therapist or psychiatrist for support with virtual visits, available by appointment, electing to choose who they want to work with for issues such as anxiety, depression, trauma and loss or relationship problems. Register

## 90-Day Retail Maintenance Program

UT SELECT members will pay less when they fill a 90-day supply of their maintenance medications at a participating pharmacy than they would pay for three 30-day supplies at a non-participating retail pharmacy. Participating pharmacies include Express Scripts Home Delivery, Walgreens and the University of Texas pharmacies. Members can also fill a 90-day supply now by using home delivery. Members should call **800-818-0015** to learn more about the program and to see if their pharmacy participates in the network.

### Filling Specialty Drugs at Accredo and the University of Texas Pharmacies

Effective September 1, 2019, Accredo<sup>®</sup>, an Express Scripts<sup>6</sup> specialty pharmacy, and the University of Texas pharmacies are now the preferred providers for all specialty medications. A specialty medication is used to treat chronic, complex conditions like multiple sclerosis, hepatitis C and cancer. By filling specialty prescriptions through Accredo and The University of Texas specialty pharmacies, specialty patients will only pay the UT SELECT copayments, get a variety of specialty pharmacy services and not be subject to covering the entire cost of medications if another pharmacy is used.

#### New Clinical Programs Effective September 1, 2019

Effective September 1, 2019, additional clinical programs will be added to the UT SELECT plans. Affected members receive letters outlining which drugs are impacted and are provided additional instructions. There are exceptions to every rule, which is why there is a clinical review process in place for Express Scripts' clinical rules. On or after September 1, 2019, a patient should have his or her doctor submit a clinical review request or appeal if they believe they should get the drug prescribed.

Express Scripts is an independent company that contracts directly with UT SELECT to administer the prescription drug program for UT SELECT.
